


BIRD OFF GEL POLYBUTENE FREE BIRD REPELLENT GEL

Building surfaces to be treated should be dry and cleaned, remove droppings, dust, etc APPLICATION DIRECTIONS:

Apply in strips in a wave -like fashion about 1/2 inch; for wider areas, more than one strip may be necessary. To remove, use scraper and then wipe the area with a rag.
